ISSUE: City of Norwalk Housing Administration Contract

REPORT: Staff overview of the proposed Housing Administration Contract with the City of Norwalk.

BACKGROUND:

The City of Norwalk currently operates an Owner-Occupied Repair (OOR) program for the community and has utilized City staff to operated the program. The City recently applied for and received additional funding from the Central lowa Housing Trust Fund to expand program offerings.

The City wishes to utilize MIPA staff to operate the OOR program for our expertise and to free up City staff time. The Norwalk City Council approved the administration contract at their February 16, 2023 Council meeting.

ISSUE: Story County Housing RFP

REPORT: Staff overview of the RFP issued for planning consulting services by Story County

BACKGROUND:

Story County initially issued an RFP for planning consulting services for the implementation of the Story County Housing Action Plan on September 30, 2022. Many of the actionable items are policy based and encourage a wide variety of housing activities. Examples of activities include: Identification of land and development sites in communities outside of Ames, evaluation of zoning ordinances and zoning requirements, and identification of funding sources and strategies for a variety of housing focused initiatives.

The Des Moines Area MPO was the only respondent to the initial RFP and was awarded a contract by the Story County Board of Supervisors on November 8, 2022. After discussion regarding priorities and responsibilities of the MPO, the MPO Board chose not to ratify the contract. Since that time, the Story County Supervisors have elected to issue a new RFP.

Staff is seeking authorization to respond to the current RFP with an updated version of the response that MPO staff initially submitted. This project fits well with MIPA because Story County and many of the communities in Story County are MIPA members. Additionally, the projects identified in the RFP are synergistic to the efforts of MIPA.

ISSUE: MIPA Update

REPORT: Staff overview of the work completed to date by MIPA for member communities and upcoming activities.

BACKGROUND:

MIPA was designated an Economic Development District on January 26, of 2022 and hired its first staff person, Caleb Knutson, on April 25. Since then, MIPA staff has been diligently working on a wide variety of projects and initiatives for communities and the region.

Since 2022, \$3.6 Million dollars have been submitted with the support of MIPA. Below is a summary of the status of the grant applications:

- Grants worth \$3.2 Million dollars assisted
 - o Grants secured worth \$1.35 Million dollars.
 - o Grants denied worth \$665,000 dollars.
 - o Grants outstanding worth \$1.6 Million dollars.

In addition to funding, MIPA Staff has been working on additional initiatives to serve member communities. These include:

- MIPA Funding Newsletter Every month MIPA staff send out a newsletter aimed at making communities aware of upcoming grant opportunities and other pertinent information that may be of interest
- Regional Broadband The State of Iowa Office of the Chief Information
 Officer (OCIO) administers broadband programs designed to increase
 access to high-speed Internet services in underserved and unserved areas
 of the State. The OCIO has recently relied on local and regional agencies
 to identify areas for future grant funding prioritization. MIPA has and is
 serving as the regional coordinating entity for member communities.
- Technical Services MIPA staff has assisted member communities for a
 variety of activities. From administering grant funding for Knoxville, to
 completing a housing study for Ogden, to updating Marion County's
 zoning code. MIPA staff is here to assist member communities complete
 their projects and achieve their community goals. Smaller technical
 services (under 10 hours of work) are included in membership dues while
 assistance on larger projects is available for an additional cost.

• **Community Visits-** Since April MIPA staff has visited 33 of the MIPA communities. Scheduling is ongoing for community visits with the goal of visiting each community at least once.

Moving forward there is also the opportunity for MIPA to administer several regional Housing Trust Funds. They are the Central Iowa Housing Trust Fund that serves Boone, Jasper, Marion, and Warren Counties, and the Story County Housing Trust that serves Story County. Both organizations are currently administered by the Des Moines Area MPO but recently there has been discussion regarding having MIPA be the contracting agency instead. MIPA serves member communities for those areas while the Des Moines Area MPO does not. Therefore, it appears that MIPA may be the better organizational fit.
