ISSUE: MIPA Designation as a Council of Governments

REPORT: Report on MIPA seeking Council of Governments designation by the State of Iowa.

BACKGROUND:

After discussion at the August Executive Committee Meeting, staff had a request from the City of Ogden to present an overview of the COG designation process and how it may impact their community. Staff presented on September 9 to the Ogden City Council. This opportunity was useful in creating a presentation that can be used in other communities seeking information on the topic and to prepare other materials to use throughout the COG designation process.

Also at the August meeting, the Greater Dallas County Development Alliance offered to assist in the preparation of a flyer for communities. MIPA staff met with the Greater Dallas County Development Alliance to discuss the creation of a two-page flyer to distribute information to communities about COG designation.

Moving forward, once materials are ready, staff will send an email to all member communities with the previously discussed information and offer to attend and present at meetings as desired by communities.

Staff is targeting early to mid-November to have a Full Board of Directors meeting to vote on whether to move forward with the designation process.
